1. PURPOSE

This Regulation implements 15 MLBS §§ 1203(d)(7) and 1207, Compact Art. IV.D, and Compact Attachment A, parts 9810.2100 and 9810.2101. The purpose of this Regulation is to designate approved products and cannabinoids, and to provide for potency limits that ensure the safe, secure, and lawful operation of cannabis-related activities within the Tribally Regulated Land and in coordination with the State of Minnesota.

2. APPROVED PRODUCT CATEGORIES AND CANNABINOIDS

2.1. Cannabis Flower and Cannabis Products

2.1.1. The following product categories, including products manufactured by changing the physical shape or texture of the listed products, are approved for sale by cannabis businesses licensed under these regulations.

- a. Dried cannabis flower products:
 - i. dried raw cannabis flower;
 - ii. fresh cannabis flower; and
 - iii. shake.
- b. Ingestible cannabis products:
 - i. edible products;
 - ii. beverage products; and
 - iii. cannabis-derived tinctures.
- c. Cannabis concentrates:
 - i. hash (hashish);
 - ii. hash oils;
 - iii. cured or live resin;
 - iv. cured or live rosin;
 - v. kief;
 - vi. full extract cannabis oil; and
 - vii. distillate.

- d. Cannabis combination products (contain both dried cannabis flower products and cannabis concentrate products):
 - i. infused pre-rolls; and
 - ii. infused dried raw cannabis flower.
- e. Transdermal or topical cannabis products intended only for application to external parts of the body.

2.2. Lower-Potency Hemp Edible Products

- 2.2.1. The following product categories are approved lower-potency hemp edible products:
 - a. edible products;
 - b. beverage products; and
 - c. hemp-derived tinctures.

2.3. Hemp-Derived Consumer Products

- 2.3.1. The following are approved hemp-derived consumer products:
 - a. dried raw hemp flower; and
 - b. hemp-derived oils intended to be consumed by combustion or vaporization of the product and inhalation of smoke, aerosol, or vapor from the product.

2.4. Cannabinoids

- 2.4.1. The following cannabinoids are approved for use in lower-potency hemp edibles: hemp-derived delta-9 tetrahydrocannabinol.
- 2.4.2. The following cannabinoids are designated as nonintoxicating and approved for use in hemp-derived consumer products:
 - a. cannabichromene (CBC);
 - b. cannabidiol (CBD);
 - c. cannabigerol (CBG); and
 - d. cannabinol (CBN).

3. POTENCY LIMITS

3.1. Potency Limits Applicable to All Regulated Products

- 3.1.1. Dried cannabis flower products and ingestible cannabis products are not subject to potency limits, provided that they comply with serving and package limitations of.
- 3.1.2. To qualify as a hemp-derived consumer product, whether or not the subject of Compacted cannabis activity, a product may not exceed 0.3 percent THC potency.

3.2. Potency Limits Applicable to Regulated Products that are the Subject of Compacted Cannabis Activity

- 3.2.1. Cannabis concentrate products designed for vaporized delivery methods for sale in the adult-use market must not exceed 80 percent THC potency.
- 3.2.2. Cannabis combination products must not exceed 50 percent total THC.
- 3.2.3. Transdermal or topical cannabis products must not exceed 1,000 mg of THC per package.

3.3. Potency Limits Applicable to Regulated Products that are Not the Subject of Compacted Cannabis Activity

- 3.3.1. The Department may issue potency limits for any regulated product that is not the subject of Compacted cannabis activity.
- 3.3.2. In the absence of such determination, the potency limits in sections 3.1 and 3.2 apply.

4. PROHIBITIONS

- 4.1.1. A regulated product with any of the following characteristics is not approved for retail sale, even if it may otherwise qualify as approved product under the foregoing sections 2-4:
 - a. appears to be a lollipop or ice cream;
 - b. appears to be the likeness, or contains characteristics of, a real or fictional person or fruit;
 - c. contains a synthetic cannabinoid;

- d. if the product is an edible product, contains an ingredient other than a cannabinoid that is not approved by the United States Food and Drug Administration for use of food; or,
- e. is designed to appeal to individuals under 21 years of age, as indicated by resemblance to candy or other shapes (*e.g.*, animals) likely to appeal to individuals under 21 years of age.
