Aaniin. In the absence of an Administration Policy Board quorum, I am writing to request the following appropriations and budget revision as follows:

1. **Education:** Appropriation of Federal Grant funds in the amount of \$300,000.00 for budget (203-3210) for the SPED – Education for the Handicapped grant funding. These funds will continue to provide IDEA Part B Special Education Services and programming for the 2025-2026 school year. (Enclosure #1)
2. **Health & Human Services:** Appropriation of Private Grant funds in the amount of \$3,000.00 for budget (223-4890) for Victim Services to be used to fund the victim services programming. (Enclosure #2)
3. **Health & Human Services:** Budget Revision in the amount of \$21,500.95 for budget (223-4460) State Funded Adult Protective Services to move funds as projected for the remainder of the fiscal year, decreasing the salary line and increasing health insurance, dental, FICA, mileage, program supplies, and activities.
