
Aaniin. In the absence of an Administration Policy Board quorum, I am writing to request the following Budget Revision/Transfers as follows:

1. **Tribal Police:** A budget transfer from Solicitor General (105-2150) to Tribal Police Department (105-1600), **for FY 2025**, in the amount of \$1,225.14 to fix various line items within the budget due to an increase in overtime and vehicle maintenance costs as submitted. (Enclosure #1)
2. **Tribal Police:** A budget revision, **for FY2025**, in the amount of \$236,595.86 for Tribal Police Department (105-1600) for FY25 year-end budget cleanup to bring negative line items to a zero balance. (Enclosure #2)
