Re: Recommendation of Contracts

Aaniin. In the absence of an Administration Policy Board quorum, I am exercising my authority under 4 MLBS §§ 2 and 6(d) to recommend the following contracts for ratification:

1. **Community Development:** Contract addendum with SCR, in the amount of \$65,000.00 due to unforeseen weather-related emergencies as well as upgrades to software to prevent additional emergencies. Contract end date is September 30, 2025.
2. **Community Development:** Contract with SCR, in the amount of \$475,000.00 to provide annual heating, cooling, HVAC and control systems service for facilities in D1, D2a, D2, and D3. Contract end date is September 30, 2026.
3. **Community Development:** Contract with Rogers Plumbing, Heating & Electrical, Inc., in the amount of \$80,000.00 to provide HVAC services for small residential projects in D1, D2a, D2, and D3. Contract end date is September 30, 2026.
4. **Community Development:** Contract with Rogers Plumbing, Heating & Electrical, Inc., in the amount of \$50,000.00 to provide Plumbing services for small residential projects in D1, D2a, D2, and D3. Contract end date is September 30, 2026.
5. **Community Development:** Contract with Ebert Companies, in the amount of \$272,200.00 for a new maintenance garage addition to the Meshakwad Community Center garage and a new detached maintenance garage at the Aazhoomog Community Center to meet maintenance and storage needs. Contract end date is September 30, 2026.
6. **Health & Human Services:** Contract addendum with RPH on the Go, extending the contract end date from December 31, 2025 to September 30, 2026.

7. **Health & Human Services:** Contract addendum with Gary Charwood, adding an additional \$7,000.00 (total contract amount \$24,800.00) to allow continued services through the end of the fiscal year. Gary provides spiritual classes about fatherhood and motherhood being sacred at the Four Winds treatment facility. The contract end date remains September 30, 2025.
