Aaniin. In the absence of an Administration Policy Board quorum, I am exercising my authority under 4 MLBS §§ 2 and 6(d) to recommend the following contracts for ratification:

1. **Natural Resources:** Contract with Minnesota Well Owners Organization, in the amount of \$30,000.00 to prepare a Quality Assurance Project Plan, host two community outreach planning events and provide event summary report. Contract end date is April 30, 2026.
2. **Community Development:** Contract with Meyer Group of Duluth, PC., in the amount of \$55,000.00 to provide architectural services and engineering services for the District 1 Hillcrest building project. Contract end date is September 30, 2026.
3. **Community Development:** Contract with Leach Electric, Inc, in the amount of \$60,000.00 to provide electrical services for small residential projects in D1, D2a, D2, and D3. Contract end date is September 30, 2026.
4. **Community Development:** Contract with CW Glass in the amount of \$60,000.00 to provide glass and window replacement and installation services for Housing Maintenance in D1, D2, D2a, and D3. Contract end date is September 30, 2026.
5. **Community Development:** Contract with Garrison Disposal in the amount of \$30,000.00 to provide delivery and pick-up of dumpsters for the D2 Housing Warehouse & Residential sites in the areas surrounding District 2. Contract end date is September 30, 2026.
6. **Community Development:** Contract with Hartl Enterprises LLC., DBA Ron's Roll-Offs in the amount of \$30,000.00 to provide delivery and pick-up of dumpsters for the D3 Housing Warehouse & TRR Rehab sites and residential sites in the surrounding area in District 3. Contract end date is September 30, 2026.


