Re: Recommendation of Contracts for Ratification

Boozhoo. In the absence of an Administration Policy Board quorum, I am exercising my authority under 4 MLBS §§ 2 and 6(d) to recommend the following agreements for ratification:

1. Contract with WEX Companies (doing business as Septic Check) in the amount of \$94,775.00 for repairs and pretreatment system replacement for the East Lake Community Center septic system;
2. Contract addendum with Pine Technical and Community College to extend the date of its original non-credit and credit certificate programs contract with Aanjibimaadizing from September 30, 2025, to July 30, 2026;
3. Contract addendum with the American Indian Community Development Corporation to extend the existing lease term for the Urban Office through September 30, 2025, and to add money to the contract in the amount of \$121,691.42 to cover rent costs for the increased lease term;
4. Contract with David Granger in the amount of \$17,100.00 to conduct mowing, weed control of sidewalks and curbs, trash pickup as needed, removal of branches in yard, etc. at Nay Ah Shing Schools;
5. Contract with Northern Pines Mental Health Center in the amount of \$279,000.00 for professional Children's Therapeutic Services and Support (CTSS) in the schools;
6. Contract with Konica-Minolta in the amount of \$13,515.00 to provide preventative maintenance of the radiology X-ray machines;
7. Contract addendum with Gary Charwood to add \$6,400.00 to the existing contract, increasing the total cost of the contract to \$17,800.0 with an end date of September 30, 2025;

8. Contract addendum with Travois Design to increase the contract amount by \$6,405.00 (to a total of \$272,405.00) for HAZMAT surveys, including lead and asbestos testing to ensure proper disposal of items; and
9. Contract with ACP CreativIT in the amount of \$10,800.00 for assistance in Nay Ah Shing School's replacement for its existing physical server, as well as an upgrade for its VM server to a new operating system.
