Re: Recommendation of Contracts

Aaniin. In the absence of an Administration Policy Board quorum, I am exercising my authority under 4 MLBS §§ 2 and 6(d) to recommend the following contracts for ratification:

1. **Community Development:** Contract with Thompson Excavating, LLC., in the amount of \$23,000.00, to provide delivery of black dirt for multiple projects, in Districts 1, 2, and 3, as requested by the Earthworks department staff. Contract end date is September 30, 2026.
2. **Community Development:** Contract addendum with Garrison Disposal, Co., adding an additional \$8,940.00, for a total contract amount of \$58,940.00. This addendum is to cover additional expenses for home demolitions of burnt structures. Contract end date remains at September 30, 2025.
3. **Community Development:** Contract for Peoples Service, Inc., in the amount of \$15,000.00, to conduct daily monitoring of Zhingwaak Water/Wastewater System, complete necessary emergency repairs to lift station and hydrant flushing in the District 3 Zhingwaak Housing Development. Contract end date is September 30, 2026.
4. **Tribal Police:** Contract for Deerwood Technologies, in the amount of \$120,000.00, to provide police department server work station equipment installation, maintenance, and repair services. Contract end date is September 30, 2026.
5. **Tribal Police:** Contract for Guardian Fleet Safety, in the amount of \$80,000.00, to provide police vehicle equipment installation, maintenance, and repair services. Contract end date is September 30, 2026.
6. **Tribal Police:** Contract for City of Garrison, Fire and Rescue, in the amount of \$47,460.00, to provide fire services in District 1. Contract end date is September 30, 2026.

7. **Tribal Police:** Contract with Dolores Mitz, in the amount of \$12,000.00, to provide transcriptions of police interviews, audio, and cameras. Contract end date is September 30, 2026.
8. **Tribal Police:** Contract with Andrea M. Hendel of Sunrise Wellness, in the amount of \$12,000.00, to provide mental health in accordance with the contract. Contract end date is September 30, 2026.
9. **Administration:** Contract with Intertribal, LLC., in the amount of \$18,500.00, to provide OneTribe TANF software support and OneTribe WIOA software support. Contract end date is September 30, 2026.
10. **Community Development:** Contract with Garrison Disposal Company, in the amount of \$275,000.00, to provide weekly roll-off at the Band's transfer station, commercial dumpsters, recycling pickup, and provide service for Districts 1 and 2 community cleanup events. Contract end date is September 30, 2026.
11. **Community Development:** Contract with Twenty4Seven Fire & Security Inc., in the amount of \$65,000.00, to provide annual inspection, monitoring & servicing of the fire protection systems at the Band's facilities in Districts 1, 2, 2a, and 3. Contract end date is September 30, 2026.
12. **Community Development:** Contract with Rum River Electric Inc., in the amount of \$25,000.00, to provide electrical services for the Band's facilities in Districts 1, 2, 2a, and 3. Contract end date is September 30, 2026.
