**Band Assembly Weekly Update: Week of April 11-15, 2022**

**Monday, April 11, 2022:** Legislative held a work session for the Band Assembly Members, and Legislative Staff.

**Work Session Agenda:** Bill: Title 25 – Cleanup bill (review comments), Bill: Title 6 – Government Employees & Ethics Code (review comments), and Bill: Title 5 – Court of Appeals (review comments)

Legal Staff reviewed proposed amendments and public comments pertaining to a Title 25 (Revisor of Statutes) bill, Title 6 (Government Employees) bill, and Title 5 (Judicial Branch) bill.

**Tuesday, April 12, 2022:** Legislative held a work session for the Band Assembly Members, and Legislative Staff.

- **Approval of Agenda:** Agenda was amended and approved.
- **Approval of Minutes:**
  - a) **Band Assembly Record:** March 30, 2022. Record was approved.
- **Reports and Presentations:**

10:00 a.m Formal Public Hearing: Title 25 Cleanup Bill. Formal Public Hearing was completed with an opening and discussion of the public comments. The hearing was completed and closed.

10:15 a.m Formal Public Hearing: Title 5 Court of Appeals Bill. Formal Public Hearing was completed with an opening and discussion of the public comments. The hearing was completed and closed.

- **Unfinished Business:**

- a) **Band Assembly Bill 20-01-30-22:** A Bill amending Title 5 of the Mille Lacs Band Statutes (“MLBS”) to establish a Healing to Wellness Court to provide intensive services and more frequent court intervention to facilitate the reunification of Band families and to prevent the breakup of such families; improve the safety and well-being of children whose families are affected by substance abuse, trauma, and mental health conditions; prevent the prenatal exposure of infants to alcohol and controlled substances; expedite family reunification and reduce the lengths of children’s out-of-home placements; strengthen families’ indigenous cultural, traditional, and community ties; reduce recidivism rates of substance abuse and promote recovery; and develop future healthy generations of Band members by promoting health and wellness for participants, their families, and Band communities.

**Sponsor: District III Representative Tabled 3/9/22, 3/23/22, 3/28/22.** Bill was taken from the table, amended, and approved with waiver of the formal reading.

- b) **Nomination:** A letter dated March 18, 2022 from Secretary-Treasurer Boyd nominating five (5) separate investment professionals to serve on the newly created Institutional Investment Committee. Per 17 MLBS § 204(g)(1), Secretary-Treasurer Boyd nominates the following individuals:

1. Carol Peterfeso to serve a 1-year term ending on December 31, 2022.
2. Andy Christensen to serve a 2-year term ending on December 31, 2023.
3. Susanna Gibbons to serve a 3-year term ending on December 31, 2024.
4. Ellen Brownell to serve a 4-year term ending on December 31, 2025.
5. Amy Jensen to serve a 4-year term ending on December 31, 2025. **Tabled 3/28/22**

- a) **Resolution 20-01-18-22:** A Resolution in Support of the Band’s Application for the Energy and Mineral Development Program Grant Through the U.S Department of the Interior Division of Energy and Mineral Development. Resolution was read and approved.
