New chassis was <u>ordered</u> by the <u>dealer</u> on 2022-08-31 (previously reported in error as "New chassis was <u>picked up</u> by the <u>builder</u> on 2022-08-31."). Expect delivery on 2023-<u>04</u>-01 (previously reported in error 2023-<u>o6</u>-01). Delivery to the dealer was 2023-04-28. VW Settlement funds expended to pay the dealer. Invoice from the dealer Boyer Trucks for \$100,996 included. VW Settlement funds of \$71,183 still to be expended. Tribal funds still to be expended.

Mille Lacs Band Department of Community Development for cost-savings measure will be reusing the belly, box and sander, along with the cab shield and some of the safety lighting components from the old truck. A new central hydraulics system will be installed along with a new front plow. New plow assembly will be fabricated by the builder for the new chassis. Found a facility that will disable the old truck engine; old truck is expected to be taken to a facility to have its engine disabled on 2023-06-01. Current projected project end date is the expected delivery date of 2023-09-01.

Development (planning work accomplished for the project):

New chassis delivered to dealer 2023-04-28.

New chassis delivered to builder 2023-05-25.

Old truck chassis expected to have its engine disabled in 2023-07-01.

Implementation (purchases, construction/installation of infrastructure, etc.):

Box, hydraulics, and plow work may begin once the chassis has been delivered.
