

Act 55-23

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget transfer(s)/revision(s) for the Legislative Branch and the Gaming Regulatory Authority for the Fiscal Year ending September 30, 2023. This bill has been drafted based on formal documents submitted by the District I Office Manager on August 4, 2023; the Executive Director of the Office of Gaming Regulatory & Compliance Gaming Regulatory Authority on August 10, 2023; and the District III Legislative Aide on August 14, 2023.

The District I Representative introduced the following Bill on the 23rd day of August, 2023.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive Branch for the Fiscal Year ending September 30, 2023.

Section 1.01: Budget revision/transfers. The Band Assembly hereby authorizes the budget revision(s)/transfer(s) of programmatic funds for the following:
