

Act 07-23

An Act Authorizing budget revisions for the Legislative Branch for the Fiscal Years ending September 30, 2022. This bill has been drafted based on formal documents submitted by the District 2 Legislative Aide on January 27, 2023; and the District I Representative on January 30, 2023.

The District III Representative introduced the following Bill on the 8th day of February, 2023.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive and Legislative Branches for the Fiscal Years ending September 30, 2022.

Section 1.01: Budget revision/transfers. The Band Assembly hereby authorizes the budget revision(s)/transfer(s) of programmatic funds for the following:

FY2022 Legislative: a budget transfer from District 1, District 3, District 1 Powwow, and Legislative to District 2 budget for year-end budget cleanup as submitted (Memo from D2 Legislative Aide dated January 25, 2023):
