

**Act 02-24**

An Act Repealing and Replacing Act 83-23 to correct the amount for “MLB Gas”. Act 83-23 authorized a supplemental appropriation for the purpose of authorizing expenditures for Mille Lacs Corporate Ventures for the Fiscal Years Ending September 30, 2023 and September 30, 2024. This bill has been drafted based on formal documents submitted by the Commissioner of Corporate Affairs on December 14, 2023.

The District I Representative introduced the following Bill on the 3<sup>rd</sup> day of January, 2024.

**BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:**

**Section 1: Governmental operations.** The Band Assembly hereby appropriates and authorizes expenditures for Mille Lacs Corporate Ventures for the Fiscal Years ending September 30, 2023, and September 30, 2024.

**Section 1.01: Appropriation and authorizations of expenditures.** The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:
