

Act 67-24

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget revision(s)/transfer(s) for the Executive and Legislative Branches for the Fiscal Years ending September 30, 2024 and September 30, 2025. This bill has been drafted based on formal documents submitted by the Commissioner of Administration on November 12, 2024; Assistant Commissioner of Administration on November 12, 2024; Commissioner of Natural Resources on October 29, 2024; Legislative Affairs Director on November 12, 2024; District 1 Legislative Assistant on November 12, 2024; and Commissioner of Finance on November 13, 2024.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:
