

Act 07-24

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing budget revision(s)/transfer(s) for the Tribal Employment Rights Office, and Gaming Regulatory Authority for the Fiscal Years ending September 30, 2023, September 30, 2024, and September 30, 2025. This bill has been drafted based on formal documents submitted by the Director of Tribal Employment Rights Office on January 9, 2024; and the Executive Director of Gaming Regulatory Authority on January 11, 2024.

The District III Representative introduced the following Bill on the 17th day of January, 2024.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby authorizes the following budget revision(s)/transfer(s) for the Tribal Employment Rights Office and Gaming Regulatory Authority for the Fiscal Years ending September 30, 2023, September 30, 2024, and September 30, 2025.

Section 1.02: Budget revision/transfers. The Band Assembly hereby authorizes the budget revision(s)/transfer(s) of programmatic funds for the following:

FY2023 Tribal Employment Rights Office: a budget transfer from the Department of Athletic Regulation to the Tribal Employment Rights Office budget for year-end budget cleanup as submitted (memo from TERO Director dated January 5, 2024):
