

Act 50-24

An Act Repealing and Replacing Act 41-24 to add the Disabled Band Member General Welfare (“DBMGW”) Assistance Benefit Program. Act 41-24 authorized Supplemental Appropriations for the August and September 2024 Tribal General Welfare Exclusion Act (“TGWEA”) Assistance Payment Program for the Fiscal Year ending September 30, 2024. The previous bill was drafted based on formal documents submitted by the Office of Management and Budget on July 23, 2024. This bill has been drafted based on formal documents submitted by the Office of Management and Budget on September 3, 2024.

The District I Representative introduced the following Bill on the 4th day of September, 2024.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2024.

Section 1.01: Appropriation and authorizations of expenditures. The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

Section 1.02: Child support. A maximum of ninety-five dollars and 00 cents (\$95.00) may be intercepted from each of the of the monthly disbursements, for the payment of ongoing child support obligations or past-due arrearages. The Band’s Child Support Enforcement Program is not required to provide any notice to obligors prior to intercepting any funds as described herein.

Section 1.03: Purposes of expenditures. All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes for which they were requested, notwithstanding any other active Band law.
