

ACT 73-24

A Bill Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget revision(s)/transfer(s) for the Executive Branch for the Fiscal Year ending September 30, 2025. This bill has been drafted based on formal documents submitted by HHS Finance dated December 10, 2024; Deputy Assistant dated December 13, 2024; and Commissioner of Finance on December 18, 2024

The District I Representative introduced the following Bill on the 18th day of December, 2024.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive Branch for the Fiscal Year ending September 30, 2025.

Section 1.01: Appropriation and authorizations of expenditures. The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:
