

Act 20-25

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget revision(s)/transfer(s) for the Executive and Legislative Branches for the Fiscal Years ending September 30, 2025. This bill has been drafted based on formal documents submitted by the HHS Finance dated April 11, 2025; the Tribal Police Office Manager dated March 26, 2025; the Commissioner of Finance dated April 10, 2025.

The District II Representative introduced the following Bill on the 16th day of April, 2025.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive and Legislative Branch for the Fiscal Years ending September 30, 2025.

Section 1.02: Payroll/Budget revision/transfers. The Band Assembly hereby authorizes the budget revision(s)/transfer(s) of programmatic funds for the following:

FY2025 Health and Human Services: a payroll budget revision for Overhead as submitted (Memo from Greta Sorvik, HHS Finance dated April 11, 2025)

Overhead 221-4190 \$12,035.60-**Total**

FY2025 Tribal Police: a payroll budget revision for Tribal Police for three positions as submitted (Memo from Carla Big Bear, Office Manager dated March 26, 2025)

Tribal Police 105-1600 \$22,778.40-**Total**

FY2025 Office of Management & Budget: a payroll budget revision for the Office of Management & Budget as submitted (Memo from Mel Towle, Commissioner of Finance dated April 10, 2025)

OMB 101-2100 \$90,680.51-**Total**

Section 1.03: Grant funds. All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2024, as appropriate. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified immediately so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.


Section 1.04: Purposes of expenditures. All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes for which they were requested, notwithstanding any other active Band law.
