

Act 07-25

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget & payroll revision(s)/transfer(s) for the Executive, Legislative, and Judicial branch for the Fiscal Years ending September 30, 2024 and September 30, 2025. This bill has been drafted based on formal documents submitted by the Executive Director of Athletic Regulation dated January 31, 2025; Formal documents from Legislative Affairs Director dated February 05, 2025; HHS Finance on February 04, 2025 and February 05, 2025; formal documents from Court Administrator dated February 04, 2025.

The District III Representative introduced the following Bill on the 12th day of February, 2025.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive and Legislative Branch for the Fiscal Years ending September 30, 2024 and September 30, 2025.

Section 1.02: Budget revision/transfers. The Band Assembly hereby authorizes the budget/Payroll revision(s)/transfer(s) of programmatic funds for the following:

FY2024 Department of Athletic Regulation: a budget revision and transfer to move monies from District III budget to the DAR budget to cover deficit and close out FY 24 budget as submitted. (Memo from Executive Director of Athletic Regulation dated January 31, 2025)

Section 1.03: Grant funds. All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2024, as appropriate. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified immediately so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.


Section 1.04: Purposes of expenditures. All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes for which they were requested, notwithstanding any other active Band law.
