

Act 37-25

An Act Authorizing a Supplemental Appropriation for the purpose of authorizing expenditures and budget/payroll revision(s)/transfer(s) for the Executive branch for the Fiscal Year ending September 30, 2025 and September 30, 2026. This bill has been drafted based on formal documents submitted by the Chief Executive dated August 5, 2025.

The District III Representative introduced the following Bill on the 13th day of August, 2025.

BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive Branch for the Fiscal Year ending September 30, 2025 and Fiscal Year ending September 30, 2026.

Section 1.01: Appropriation and authorizations of expenditures. The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

Tribal Operations Fiscal Year 2025 Supplemental Cross-Reference

Section 1.02: Budget/Payroll revision/transfers. The Band Assembly hereby authorizes the budget/payroll revision(s)/transfer(s) of programmatic funds for the following:

FY2025 Education: a budget revision to move monies within the budget as submitted. (CE Wind Memo, at end of memo requesting a budget revision)

Section 1.03: Grant funds. All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2025, as appropriate. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified immediately so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.04: Purposes of expenditures. All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes for which they were requested, notwithstanding any other active Band law.
