IT IS ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for the Executive Branch for the Fiscal Year ending September 30, 2022.

Section 1.01: Appropriation and authorizations of expenditures. The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

Pursuant to the powers listed in 3 MLBS § 17(c) "...each bill shall be personally delivered to the Chief Executive, who shall have five calendar days from the date of receipt to either sign the bill into law, or veto the bill...In the event he neither signs the bill or vetoes it, it shall become law without his signature after the expiration of five days from the date of receipt of the bill."

Band Assembly Bills 20-01-48-22 and 20-01-49-22 was delivered to the Chief Executive Office on May 06, 2022 at 1:40 p.m. and as of May 18, 2022 at 4:01 p.m. the Bills still have not been returned to the Legislative with the Chief Executive's signature nor was there a written veto message containing objections to either of the Bills.
