

Ordinance 28-22

An Ordinance of Supplemental Appropriation for Mille Lacs Corporate Ventures for Maadaadizi Inc., Mille Lacs Wastewater Inc., Grand Makwa-Wewinabi Inc., Grindstone Laundry, and Foxtrot Marketing for the Fiscal Year ending September 30, 2022. This bill has been drafted based on formal documents submitted by the Commissioner of Corporate Affairs on January 21, 2022.

The District III Representative introduced the following Bill on the 16th day of February, 2022.

IT IS ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures for Mille Lacs Corporate Ventures for the Fiscal Year ending September 30, 2022.

Section 1.01: Appropriation and authorizations of expenditures. The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:


