

**Ordinance 11-22**

An Ordinance of Supplemental Appropriation for the December 2021 and January 2022 Tribal Per Capita Distribution for Adults and Minor Trust for the Fiscal Year ending September 30, 2022. This bill has been drafted based on formal documents submitted by the Office of Management and Budget on November 9, 2021.

The District I Representative introduced the following Bill on the 17<sup>th</sup> day of November, 2021.

**IT IS ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:**

**Section 1: Governmental operations.** The Band Assembly hereby appropriates and authorizes expenditures for the Legislative Branch for the Fiscal Year ending September 30, 2022.

**Section 1.01: Appropriation and authorizations of expenditures.** The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:

**Section 1.02: Purposes of expenditures.** All funds appropriated are maximum fund amounts and shall not be exceeded. Funds must be utilized for the purposes for which they were requested, notwithstanding any other active Band Ordinance.

**Section 1.03: Judgments or Liens for Child Support Payments or Arrearages.** The Office of Management and Budget shall not make any per capita distributions under this Ordinance until the Mille Lacs Band of Ojibwe Child Support Enforcement Program has submitted a list of per capita garnishments, updated after adoption of this Ordinance for the month of December 2021, pursuant to 24 MLBS § 3353 (a) 6. Any notice requirements for the withholding of per capita income for child support purposes are hereby waived.


