

Ordinance 13-22

An Ordinance of Supplemental Appropriation for the purpose of authorizing expenditures and budget revisions/transfers for the Legislative Branch for the Fiscal Year ending September 30, 2021. This bill has been drafted based on formal documents submitted by the Legislative Branch on November 17, 2021.

The District II Representative introduced the following Bill on the 24th day of November, 2021.

IT IS ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:

Section 1: Governmental operations. The Band Assembly hereby appropriates and authorizes expenditures and budget revisions/transfers for the Legislative Branch for the Fiscal Year ending September 30, 2021.

Section 1.01: Budget revision/transfers. The Band Assembly hereby authorizes the budget revision(s)/transfer(s) of programmatic funds for the following:

FY2021 Legislative: a budget revision to move monies within the Legislative budget for year-end clean up as submitted (Memo from the Legislative Affairs Director dated November 10, 2021):

Pursuant to the powers listed in 3 MLBSA § 16(c) "...each bill shall be personally delivered to the Chief Executive, who shall have five calendar days from the date of receipt to either sign the bill into law, or veto the bill...In the event he neither signs the bill or vetoes it, it shall become law without his signature after the expiration of five days from the date of receipt of the bill."

Band Assembly Bill 19-04-13-21 was delivered to the Chief Executive Office on November 24, 2021 at 11:54 a.m. It still has not been returned to the Legislative with the Chief Executive's signature nor a written veto message containing objections to the Bill. At this time, the Bill becomes law and will be forwarded to The Office of Management and Budget to be processed.
