

**Act 93-22**

An Act of Supplemental Appropriation for the purpose of authorizing expenditures for the Legislative and Judicial Branches for the Fiscal Year ending September 30, 2023. This bill has been drafted based on formal documents submitted by the Revisor of Statutes and Legislative Affairs Director on November 2, 2022; Legislative Affairs Director on November 9, 2022; District 2 Legislative Aide on November 14, 2022; and the Court Administrator on November 18, 2022.

The District I Representative introduced the following Bill on the 30<sup>th</sup> day of November, 2022.

**BE IT ENACTED BY THE BAND ASSEMBLY OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE:**

**Section 1: Governmental operations.** The Band Assembly hereby appropriates and authorizes expenditures for the Legislative and Judicial Branches for the Fiscal Year ending September 30, 2023.

**Section 1.01: Appropriation and authorizations of expenditures.** The Band Assembly hereby appropriates and authorizes the expenditures of supplemental programmatic funds for the following:
