BAND ASSEMBLY BILL 03-02-20-89

A bill of amendment to revise appropriations of the Court of Central Jurisdiction for fiscal year 1989.

The District II Representative introduced the following bill on the ^{5th} day of ~~August~~ ^{September} 1989.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of revising appropriations for the Court of Central Jurisdiction, the sum of forty three thousand five hundred dollars and no cents for fiscal year 1989.

Chapter 15

Section 1: Judicial Compensation. The Band Assembly hereby authorizes twenty three thousand five hundred dollars and no cents as compensation for the services of the Court of Central Jurisdiction to be disbursed in the following manner:

Section 1.01: There is hereby appropriated six thousand dollars and no cents for the Chief Justice of the Court of Central Jurisdiction.

Section 1.02: There is hereby appropriated four thousand dollars and no cents as compensation for the Justices of the Court of Central Jurisdiction for those times when the full court meets in special session during any of the four terms of the Court.

Section 1.03: There is hereby appropriated eight hundred dollars and no cents for the individual justices of the Court of Central Jurisdiction for each case in which a trial on the merits is conducted. This compensation includes the conduct of show cause hearings, all preliminary hearings and trials to which the justices issue findings of fact, conclusions of law and orders for judgment.

Section 1.04: There is hereby appropriated one thousand two hundred dollars and no cents for the individual justices of the Court of Central Jurisdiction for each show cause hearing that does not result in judicial certification of any said case that is not certified for trial on the merits.

Section 1.05: There is hereby appropriated eleven thousand four hundred dollars and no cents for the Clerk of the Court of Central Jurisdiction during fiscal year 1989.

Section 2: Indigent Defendant Legal Fee. The Band Assembly hereby authorizes the amount of nine hundred dollars and no cents for the payment of an appropriate fee to any Legal Officer licensed to practice law in the Court of Central Jurisdiction in defense of any lawsuit filed against any member of the Mille Lacs Band of Chippewa Indians in Band court or where the Band has a legal right interest for any case filed in State Court.

Section 3: Library. The Band Assembly hereby authorizes three hundred sixty nine dollars and no cents for the purchase of reference materials of a legal nature which will aid the Court in the performance of their judicial duties.

Section 4: Equipment. The Band Assembly hereby authorizes four thousand dollars and no cents for the purchase of equipment which will aid the Court in the performance of their judicial duties.

Section 5: Court Supplies. The Band Assembly hereby authorizes four hundred ten dollars and twenty nine cents for purchase of supplies which will aid the Court in the performance of their judicial duties.

Section 6: Printing/Postage. The Band Assembly hereby appropriates six hundred dollars and no cents for printing and postage which will aid the Court in the performance of their judicial duties.

Section 7: Travel. The Band Assembly hereby authorizes three thousand five hundred dollars and no cents for travel expenses incurred in the performance of legal duties on behalf of the Court of Central Jurisdiction.

Section 8: Telephone. The Band Assembly hereby appropriates one hundred twenty dollars and seventy one cents for telephone expenses incurred in the performance of legal duties on behalf of the Court of Central Jurisdiction.

Section 9: Service of Process. The Band Assembly hereby authorizes two hundred dollars and no cents for expenses incurred by the Law Enforcement Administration of the Band in the service of process to which the Non Removable Mille Lacs Band of Chippewa Indians is the plaintiff in any cause of action filed in the Court of Central Jurisdiction.

Section 10: Technical Assistance. The Band Assembly hereby appropriates two thousand four hundred dollars and no cents for training and technical assistance of the Court of Central Jurisdiction.

Section 11: Compensation for Juries. The Band Assembly hereby appropriates three hundred dollars and no cents as compensation to members of the Non Removable Mille Lacs Band of Chippewa Indians who serve in the capacity as jurors to any civil or criminal cause of action filed in the Court of Central Jurisdiction.

Section 12: Communications. The Band Assembly hereby authorizes five hundred dollars and no cents for communication expenses which will aid the Court in the performance of their judicial duties.

Section 13: Space Cost. The Band Assembly hereby authorizes three thousand dollars and no cents for space costs of the Court of Central Jurisdiction.

Section 14: Tribal Prosecutor. The Band Assembly hereby authorizes three thousand five hundred dollars and no cents for a tribal prosecutor under the Court of Central Jurisdiction.

Section 15: Audit. The Band Assembly hereby authorizes three hundred dollars and no cents for the implementation of Attachment P, Circular A-128 single audit of grants and contracts within the Court of Central Jurisdiction.
