

BAND ASSEMBLY BILL 03-02-21-89

A bill of appropriation for the Self Governance - Demonstration Project for the Executive Branch of tribal government for fiscal year 1989-1990.

The District II Representative introduced the following bill on the 8th day of September, 1989.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians appropriations for the Self Governance - Demonstration Project for fiscal year 1989-1990.

Chapter ____

Section 1: Self Governance - Demonstration Project. The Band Assembly hereby appropriates programmatic funds for the Self Governance - Demonstration Project.

Section 1.01: Any grant or contract not specifically listed in Section 1 shall be excluded from appropriation in this bill and as such the Senior Accountants shall be precluded from authorizing any expenditure until said time of appropriation.

Section 1.02: The Band Assembly hereby appropriates the expenditure of one hundred thousand dollars and no cents for the Self Governance - Demonstration Project. This fund appropriated is the maximum fund amount and shall not be exceeded.

Section 1.021: Increase in funding to this grant is subject to supplemental appropriation by the Band Assembly.

Section 1.022: Decreases in funding to this grant shall automatically be decreased by the Band Assembly upon notification of the appropriate federal or state agency.

Section 2: Personnel. The Band Assembly hereby approves the personnel position requisition of the Chief Executive and allocates two (2) full time positions. The Band Assembly hereby authorizes an amount of thirty three thousand four hundred eighty dollars and no cents as salary compensation and seven thousand three hundred sixty six dollars and no cents for fringe benefits related to salary.

Section 2.01: Salary increase based upon cost of living or merit shall not be implemented unless authorized by the Administrative Policy Board.

Section 3: Travel. The Band Assembly hereby authorizes fourteen thousand three hundred fifty six dollars and no cents for travel in the categories of monthly mileage, trip travel and trip per diem.

Section 4: Telephone. The Band Assembly hereby authorizes one thousand dollars and no cents for telephone expenses under the Self Governance - Demonstration Project.

Section 5: Supplies. The Band Assembly hereby authorizes one thousand dollars and no cents for supplies under the Self Governance - Demonstration Project.

Section 6: Photocopies. The Band Assembly hereby authorizes one thousand dollars and no cents for photocopies under the Self Governance - Demonstration Project.

Section 7: Agreement Development. The Band Assembly hereby authorizes fifteen thousand dollars and no cents for agreement development.

Section 8: Tribal Government Review. The Band Assembly hereby authorizes twenty five thousand seven hundred ninety eight dollars and no cents for tribal government review.

Section 9: Audit. The Band Assembly hereby authorizes one thousand dollars and no cents for the implementation of Attachment P, Circular A-128 single audit of grants and contracts within the Self Governance - Demonstration Project.
