Band Assembly Bill 04-02-03-91

A bill of tribal government to appropriate funds for the operation of the Court of Central Jurisdiction for fiscal year 1991.

The District I Representative introduced the following bill on the 26th day of October, 1990.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians the purpose of appropriating funds for the operation of the Court of Central Jurisdiction, the sum of fifty four thousand fifty dollars and no cents (\$54,050) for fiscal year 1991.

Chapter 75

<u>Section 1:</u> Court of Central Jurisdiction. The Band Assembly hereby appropriates programmatic funds or the Court of Central Jurisdiction for the following grants and contracts: Great Lakes Indian Fish and Wildlife Commission and Minnesota Chippewa Tribe.

<u>Section 1.01:</u> Any grant or contract not specifically listed in Section 1 above shall be excluded from appropriation in this bill and as such the Senior Accountants shall be precluded from authorizing any expenditure until said time of appropriation occurs.

<u>Section 1.02:</u> The Band Assembly hereby appropriates and authorizes the expenditure of fifty four thousand fifty dollars (\$54,050.00) for the Court of Central Jurisdiction.

<u>Section 1.03:</u> The Band Assembly hereby appropriates and authorizes the expenditure of programmatic funds and specifically allocates these funds for the following grants and contracts: Great Lakes Indian Fish and Wildlife Commission-\$35,000 and Minnesota Chippewa Tribe-\$19,050.

<u>Section 1.031:</u> Increases in funding to any grant or contract listed above shall be subject to supplemental appropriation by the Band Assembly.

<u>Section 1.032:</u> Decreases in funding to any grant or contract listed above shall automatically be decreased by the Band Assembly upon notification of the appropriate federal or state agency.

<u>Section 2:</u> Personnel. The Band Assembly hereby approves the personnel position requisition of the Chief Executive and allocates 2 personnel positions. The Band Assembly hereby authorizes an amount of thirty five thousand six hundred ninety seven dollars and no cents as salary compensation and seven thousand eight hundred sixty four dollars and sixty cents for fringe benefits related to salary.

<u>Section 3</u>: Communication. The Band Assembly hereby authorizes one thousand seventy five dollars and no cents for communication expenses for the Court of Central Jurisdiction.

<u>Section 4:</u> Travel/Per Diem/Technical Assistance. The Band Assembly hereby authorizes two thousand eight hundred twenty three dollars and forty cents for travel in the categories of monthly mileage, trip travel, trip per

diem, in-state travel, and out-of-state travel to technical assistance workshops.

<u>Section 5:</u> Supplies. The Band Assembly hereby authorizes four hundred seventy five dollars and no cents for supplies which will aid the Court in the performance of their judicial duties.

<u>Section 6:</u> Space Cost. The Band Assembly hereby authorizes one thousand five hundred forty dollars and no cents for space costs of the Court of Central Jurisdiction.

<u>Section 7:</u> Audit. The Band Assembly hereby authorizes three hundred dollars and no cents for the implementation of Attachment P, Circular A-128 single audit of grants and contracts within the Court of Central Jurisdiction.

<u>Section 8:</u> Court of Appeals. The Band Assembly hereby authorizes three thousand three hundred dollars and no cents for expenses for the Court of Appeals within the Court of Central Jurisdiction.

Section 9: Court Costs. The Band Assembly hereby authorizes nine hundred seventy five dollars and no cents for court costs expenses in all

proceedings of trials for the Court of Central Jurisdiction.

<u>Section 10:</u> Fund Transfer. The Band Assembly hereby authorizes the Court of Central Jurisdiction to transfer 10% if the program is under one hundred thousand dollars and transfer 5% of funds if the program is one hundred thousand dollars or over.
