Band Assembly Bill 04-02-05-91

A bill of tribal government to appropriate funds from the Ne Ia Shing Clinic Trust Fund Account of the Mille Lacs Band of Chippewa Indians.

The District Representative introduced the following bill on the 26th day of October, 1990.

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Ne Ia Shing Clinic Trust Fund Account.

Chapter 74

Section 1. Trust Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of seventeen thousand eight hundred seven dollars and twenty eight cents (\$17,807.28) from the Ne Ia Shing Clinic Trust Fund Account for the following:

Section 1.01: The Band Assembly hereby appropriates one thousand eight hundred sixty dollars and no cents for the upgrade of driveways and installation of handicap handrails and ramps for the elders of District III; and,

Section 1.02: The Band Assembly hereby appropriates ten thousand dollars and no cents for the creation of an account named Dental Lab for the construction of dentures, bridges, space maintainers and any other dental laboratory procedures needed for proper treatment of Band members; and,

<u>Section 1.03:</u> The Band Assembly hereby appropriates two thousand dollars from the Third Party Account for the creation of an account named Emergency Medical Travel for various members of the Band; and,

Section 1.04: The Band Assembly hereby appropriates two hundred sixty nine dollars and no cents for the upgrade of a driveway for a handicapped Band member in District I; and;

Section 1.05: The Band Assembly hereby appropriates one thousand five hundred ninety two dollars and sixty eight cents to be paid to the United States Department of Agriculture for spoiled butter at the Food Distribution Program; and,

Section 1.06: The Band Assembly hereby appropriates ninety eight dollars and no cents to Northwestern Artificial Limb & Brace Company for orthonedic shoes for a Band member; and,

Section 1.07: The Band Assembly hereby appropriates thirty seven dollars and sixty cents to a committeeperson for mileage to attend the meeting; and,

Section 1.08: The Band Assembly hereby appropriates one thousand nine hundred fifty dollars and no cents for the upgrade of driveways and installation of handicap handrails and ramps for the elders of District II.
