Band Assembly Bill 04-03-11-91

A bill of tribal government to appropriate funds from the Ne Ia Shing Clinic Trust Fund Account of the Mille Lacs Band of Chippewa Indians.

The District I Representative introduced the following bill on the 9th day of April, 1991

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Ne Ia Shing Clinic Trust Fund Account.

Chapter 74

- Section 1. Trust Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of two thousand three hundred sixteen dollars and fifty five cents (\$2316.55) from the Ne Ia Shing Clinic Trust Fund Account for the following:
- <u>Section 1.01:</u> The Band Assembly hereby appropriates nine hundred fourteen dollars and eighty six cents for eyeglass expenses to Dr. Beebe's Office; and,
- <u>Section 1.02:</u> The Band Assembly hereby appropriates six hundred thirty four dollars and eighty cents for eyeglass expenses to Mora Eye Clinic; and,
- Section 1.03: The Band Assembly hereby appropriates eighty nine dollars and no cents for eyeglass expenses to Dr. Bye's Office; and
- <u>Section 1.04:</u> The Band Assembly hereby appropriates three hundred thirteen dollars and fifteen cents for clinic charges for a Band member at St. Alexius Medical Center; and,
- Section 1.05: The Band Assembly hereby appropriates twelve dollars and no cents for clinic charges for a Band member at Mid Dakota Clinic, P.C.; and,
- <u>Section 1.06:</u> The Band Assembly hereby appropriates one hundred eighty three dollars and seventy cents to Central Lakes Medical Center for patient charges; and,
- <u>Section 1.07:</u> The Band Assembly hereby appropriates twenty nine dollars and no cents to Columbia Park Medical Group for a Band member's expenses; and

<u>Section 1.08:</u> The Band Assembly hereby appropriates twenty seven dollars and twenty four cents for reimbursement to a Band member for eyeglass purchase; and,

Section 1.09: The Band Assembly hereby appropriates one hundred twelve dollars and eighty cents for mileage for a committee member to attend the board meetings.
