

Band Assembly Bill 04-04-11-92

A bill of supplemental appropriation for the Court of Central Jurisdiction of tribal government of the Mille Lacs Band of Chippewa Indians for fiscal year 1992.

The District I Representative introduced the following bill on the 14th day of November, 1991.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians a supplemental appropriation for the Court of Central Jurisdiction for fiscal year 1992.

Chapter 75

Section 1: Amendment to Section 1.02. The Band Assembly hereby authorizes the supplemental appropriation of the Net Revenue Allocation by one hundred two thousand dollars and no cents (\$102,000.00) which amends the total to read one hundred sixty six thousand six hundred twelve dollars and no cents (\$166,612.00) for the Court of Central Jurisdiction.

Section 1.01: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds and specifically allocates these funds for the following: Net Revenue Allocation-Court - \$102,000.00. Any grant or contract not specifically listed in Section 1 above shall be excluded from supplemental appropriation in this bill and as such the Senior Accountants shall be precluded from authorizing any expenditure until said time of supplemental appropriation occurs.

Section 2: Amendment to Section 2: Personnel. The Band Assembly hereby approves and authorizes an additional amount of two thousand two hundred ninety two dollars and no cents (\$2,292.00) for fringe benefits related to salary. This brings the total to nine thousand five hundred forty five dollars and no cents (\$9,545.00) for fringe benefits related to salary for the Court of Central Jurisdiction.

Section 3: Amendment to add new section. Space Cost. The Band Assembly hereby approves and authorizes one thousand seven hundred forty four dollars and no cents (\$1,744.00) for space cost for the Court of Central Jurisdiction.

Section 4: Amendment to add new section. Audit. The Band Assembly hereby approves and authorizes one thousand seven hundred one dollars and sixty one cents (\$1,701.61) for audit of grants and contracts within the Court of Central Jurisdiction.

Section 5: Amendment to add new section. Equipment and Supplies. The Band Assembly hereby approves and authorizes ten thousand dollars and no cents (\$10,000.00) for equipment and supplies for the Court of Central Jurisdiction.

Section 6: Amendment to add new section. Communications. The Band Assembly hereby approves and authorizes ten thousand dollars and no cents (\$10,000.00) for communications within the Court of Central Jurisdiction.

Section 7: Amendment to add new section. Show Cause/Trial. The Band Assembly hereby approves and authorizes ten thousand dollars and no cents (\$10,000.00) for show cause/trial within the Court of Central Jurisdiction.

Section 8: Amendment to add new section. Jury. The Band Assembly hereby approves and authorizes five thousand dollars and no cents (\$5,000.00) for jury within the Court of Central Jurisdiction.

Section 9: Amendment to add new section. Court of Appeals. The Band Assembly hereby approves and authorizes ten thousand dollars and no cents (\$10,000.00) for Court of Appeals within the Court of Central Jurisdiction.

Section 10: Amendment to add new section. Travel. The Band Assembly hereby approves and authorizes nineteen thousand three hundred eighteen dollars and thirty nine cents (\$19,318.39) for travel for the Court of Central Jurisdiction.

Section 11: Amendment to add new section. Per Diem. The Band Assembly hereby approves and authorizes fifteen thousand dollars and no cents (\$15,000.00) for per diem for the Court of Central Jurisdiction.

Section 12: Amendment to add new section. Technical Assistance. The Band Assembly hereby approves and authorizes eleven thousand nine hundred forty four dollars and no cents (\$11,944.00) for technical assistance within the Court of Central Jurisdiction.

Section 13: Amendment to add new section. Court Administrator/ Consultant. The Band Assembly hereby approves and authorizes five thousand dollars and no cents (\$5,000.00) for Court Administrator/ Consultant within the Court of Central Jurisdiction.
