

ORDINANCE 32 - 92

An ordinance of tribal government to appropriate funds for the operation of the Court of Central Jurisdiction for fiscal year 1993.

The District I Representative introduced the following bill on the 22nd day of September, 1992.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds for the operation of the Court of Central Jurisdiction for fiscal year 1993.

Chapter 75

Section 1: Court of Central Jurisdiction. The Band Assembly hereby appropriates programmatic funds for the Court of Central Jurisdiction for the following grants and contracts: Great Lakes Indian Fish and Wildlife Commission, Bureau of Indian Affairs Compact and Net Revenue Allocations.

Section 1.01: Any grant or contract not specifically listed in Section 1 above shall be excluded from appropriation in this bill and as such the Senior Accountants shall be precluded from authorizing any expenditure until said time of appropriation occurs.

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of one hundred sixty six thousand six hundred twelve dollars and no cents (\$ 166,612.00) for the Court of Central Jurisdiction.

Section 1.03: The Band Assembly hereby appropriates and authorizes the expenditure of programmatic funds and specifically allocates these funds for the following grants and contracts: Great Lakes Indian Fish and Wildlife Commission - \$ \$ 38,951.00, Bureau of Indian Affairs Compact - \$ \$ 25,661.00 and Net Revenue Allocations - \$ 102,000.00.

Section 1.031: Increases in funding to any grant or contract listed above shall be subject to supplemental appropriation by the Band Assembly.

Section 1.032: Decreases in funding to any grant or contract listed above shall automatically be decreased by the Band Assembly upon notification of the appropriate federal or state agency.

Section 2: Personnel. The Band Assembly hereby approves the personnel position requisition of the Chief Executive and allocates 4 personnel positions. The Band Assembly hereby authorizes an amount of eighty four thousand one hundred twenty four dollars and no cents (\$ 84,124.00) as salary compensation and twenty one thousand eight hundred seventy two dollars and twenty four cents (\$ 21,872.24) for fringe benefits related to salary.

Section 3: Communication. The Band Assembly hereby authorizes two thousand five hundred dollars and no cents (\$ 2,500.00) for communication expenses for the Court of Central Jurisdiction.

Section 4: Travel/Per Diem. The Band Assembly hereby authorizes seventeen thousand four hundred twenty three dollars and fifty two cents (\$ 17,423.52) for travel in the categories of monthly mileage, trip travel, trip per diem, in-state travel and out-of-state travel.

Section 5: Technical Assistance. The Band Assembly hereby appropriates five thousand dollars and no cents (\$ 5,000.00) for expenses for technical assistance under the Court of Central Jurisdiction.

Section 6: Supplies/Equipment. The Band Assembly hereby authorizes two thousand three hundred forty seven dollars and twelve cents (\$ 2,347.12) for supplies and equipment which will aid the Court in the performance of their judicial duties.

Section 7: Space Cost. The Band Assembly hereby authorizes four thousand dollars and no cents (\$ 4,000.00) for space costs of the Court of Central Jurisdiction.

Section 8: Audit. The Band Assembly hereby authorizes one thousand six hundred sixty six dollars and twelve cents (\$ 1,666.12) for the implementation of Attachment P, Circular A-128 single audit of grants and contracts within the Court of Central Jurisdiction.

Section 9: Court of Appeals. The Band Assembly hereby authorizes five thousand dollars and no cents (\$ 5,000.00) for expenses for the Court of Appeals within the Court of Central Jurisdiction.

Section 10: Show Cause/Trial/Jury. The Band Assembly hereby authorizes seven thousand dollars and no cents (\$ 7,000.00) for court cost expenses in all proceedings of trials for the Court of Central Jurisdiction.

Section 11: Tribal Prosecution. The Band Assembly hereby authorizes five thousand dollars and no cents (\$ 5,000.00) for tribal prosecution expenses under the Court of Central Jurisdiction.

Section 12: Indirect Cost. The Band Assembly hereby authorizes ten thousand six hundred seventy nine dollars and no cents (\$ 10,679.00) for indirect cost expenses for the Court of Central Jurisdiction.

Section 13: Fund Transfer. The Band Assembly hereby authorizes the Court of Central Jurisdiction to transfer 10% of funds if the program is under one hundred thousand dollars and transfer 5% of funds if the program is one hundred thousand dollars or over.
