

ORDINANCE 25 - 92

An ordinance of tribal government to appropriate funds from the Band revenues derived from the May 1992 distribution of Grand Casino Hinckley Revenues.

The District III Representative introduced the following bill on the 31st day of July, 1992.

Preamble

It is enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Band revenues derived from the May 1992 distribution of Grand Casino Hinckley Revenues.

Chapter

Section 1: Band Revenue - Grand Casino Hinckley Revenues. The Band Assembly hereby appropriates and authorizes two hundred fifty two thousand four hundred eleven dollars and eighty nine cents (\$ 252,411.89) from the Band revenues derived from the May 1992 distribution of the Grand Casino Hinckley revenues for the following:

Section 1.01: The Band Assembly hereby appropriates fifty thousand dollars and no cents (\$ 50,000.00) for the start up funds of the Mille Lacs Band Housing Authority.


Section 1.02: The Band Assembly hereby appropriates thirty six thousand dollars and no cents (\$ 36,000.00) for filtronics expenses for Public Works.

Section 1.03: The Band Assembly hereby appropriates one hundred sixty six thousand four hundred eleven dollars and eighty nine cents (\$ 166,411.89) for the Comstock and Davis billing.



ORDINANCE 25 - 92


