Band Assembly Bill 04-04-13-92

A bill of tribal government to appropriate funds from the Net Revenue Allocation Account of the Mille Lacs Band of Chippewa Indians.

The District II Representative introduced the following bill on the 16th day of December, 1991.

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Net Revenue Allocation Fund Account.

Chapter 81

Section 1. Net Revenue Allocation Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of thirteen thousand eight hundred fifty two dollars and fifty seven cents (\$13,852.57) from the Net Revenue Allocation Account for the following:

<u>Section 1.01:</u> The Band Assembly hereby appropriates one thousand two hundred seven dollars and fifty seven cents (\$1,207.57) from the Elderly Housing Account of the Mille Lacs Reservation.

<u>Section 1.02</u>: The Band Assembly hereby appropriates seven thousand dollars and no cents (\$7,000.00) from the Land Reacquisition Account of the Mille Lacs Reservation.

Section 1.03: The Band Assembly hereby appropriates four thousand three hundred seventy five dollars and no cents (\$4,375.00) from the Community Donations Account for District II and District III of the Mille Lacs Reservation.

<u>Section 1.04</u> The Band Assembly hereby appropriates two hundred eighty dollars and no cents (\$280.00) to reimburse the District III account from the Community Donations Account of the Mille Lacs Reservation for the Halloween Party and Boxing Club.

Section 1.06: The Band Assembly hereby appropriates four hundred fifty dollars and no cents (\$450.00) to reimburse the District II account from the Community Donations Account of the Mille Lacs Reservation for the Halloween Party.

<u>Section 1.05:</u> The Band Assembly hereby appropriates five hundred forty dollars and no cents (\$540.00) for the purchase of chairs for the District III center of the Mille Lacs Reservation.
