

Band Assembly Bill 05-01-01-92

*An Ordinance*

(A bill) of tribal government to appropriate funds from the Net Revenue Allocation Account of the Mille Lacs Band of Chippewa Indians.

The District III Representative introduced the following bill on the 4th day of February, 1992.

Preamble

*It is*

(Be it) enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Net Revenue Allocation Fund Account.

Chapter 81

Section 1. Net Revenue Allocation Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of fourteen thousand dollars and no cents (\$14,000.00) from the Net Revenue Allocation Account for the following:

Section 1.01: The Band Assembly hereby appropriates five thousand dollars and no cents (\$5,000.00) from the Daycare Account of the Mille Lacs Reservation.

Section 1.02: The Band Assembly hereby appropriates nine thousand dollars and no cents (\$9,000.00) from the General Government Development Account for OMB - fiscal management improvement project of the Mille Lacs Reservation.





CLERK CERTIFICATION FOR BAND ASSEMBLY BILLS


