

ORDINANCE 29 - 92

An ordinance of tribal government to appropriate funds from the Band revenues derived from the July 1992 distribution of Grand Casino-Hinckley revenues.

The District I Representative introduced the following bill on the 1st day of September 1992.

Preamble

It is enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Band revenues derived from the July 1992 distribution of Grand Casino-Hinckley revenues.

Chapter

Section 1: Band Revenue-Grand Casino Hinckley. The Band Assembly hereby appropriates nine hundred one thousand five hundred seventy two dollars and twenty one cents (\$ 901,572.21) from the Band Revenue - Grand Casino Hinckley revenues for the following:

Section 1.01: The Band Assembly hereby appropriates one hundred thousand dollars and no cents (\$ 100,000.00) for Housing which will be deducted from the proposed two million.

Section 1.02: The Band Assembly hereby appropriates one hundred thousand dollars and no cents (\$ 100,000.00) for Elderly Housing.

Section 1.03: The Band Assembly hereby appropriates five hundred fifty thousand dollars and no cents (\$ 550,000.00) for the proposed Band loan program.

Section 1.04: The Band Assembly hereby appropriates thirty seven thousand five hundred sixty nine dollars and sixty cents (\$ 37,569.60) for the water tower.

Section 1.05: The Band Assembly hereby appropriates ten thousand six hundred twelve dollars and sixteen cents (\$ 10,612.16) for highway 169 and traffic study.

Section 1.06: The Band Assembly hereby appropriates eight thousand three hundred ninety two dollars and ninety eight cents (\$ 8,392.98) for soil borings for the water tower.

Section 1.07: The Band Assembly hereby appropriates twenty three thousand eight hundred forty two dollars and forty nine cents (\$ 23,842.49) for Comstock and Davis.

Section 1.08: The Band Assembly hereby appropriates fifty three thousand one hundred fifty four dollars and ninety eight cents (\$ 53,154.98) for unemployment taxes for 1991 and 1992.

Section 1.09: The Band Assembly hereby appropriates eighteen thousand dollars and no cents (\$ 18,000.00) to be reimbursed back to the Administration Operations Account.
