Band Assembly Bill 04-04-12-92

A bill of supplemental appropriation for the Human Services Administration of the Executive Branch of tribal government of the Mille Lacs Band of Chippewa Indians for fiscal year 1992.

The District III Representative introduced the following bill on the 12th day of December , 1991.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians a supplemental appropriation for the Human Services Administration for fiscal year 1992.

Chapter 70

<u>Section 1:</u> Amendment to Section 1. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of programmatic funds for the Human Services Administration for the following grant and contract: McKnight Planning Grant.

<u>Section 1.02:</u> Amendment to Section 1.02. The Band Assembly hereby authorizes the supplemental appropriation of the McKnight Planning Grant which amends the total to read one million five hundred thirty eight thousand one hundred twelve dollars and no cents (\$1,538,112.00) for the Human Services Administration.

Section 1.03: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds and specifically allocates these funds for the following: McKnight Planning Grant - \$12,078.00. Any grant or contract not specifically listed in Section 1 above shall be excluded from supplemental appropriation in this bill and as such the Senior Accountants shall be precluded from authorizing any expenditure until said time of supplemental appropriation occurs.

Section 2: Amendment to Section 5: Consultant. The Band Assembly hereby approves and authorizes an additional amount of eleven thousand dollars and no cents (\$11,000.00) for consultant expenses under the Human Services Administration. This brings the total to thirty three thousand three hundred sixty three dollars and eighty cents (\$33,363.80) related to consultant for the Human Services Administration.

Section 3: Amendment to Section 10. Indirect Cost. The Band Assembly hereby approves and authorizes an additional amount of one thousand seventy eight dollars and no cents (\$1,078.00) for Indirect Cost under the Human Services Administration. This brings the total to one hundred seventeen thousand four hundred ninety five dollars and no cents related to Indirect Cost for the Human Services Administration.
