ORDINANCE 26-92

An ordinance of tribal government to appropriate funds from the Band revenue derived from the June 1992 distribution of Grand Casino-Hinckley Revenues.

The District II Representative introduced the following bill on the 31st day of July, 1992.

Preamble

It is enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Band revenue derived from the June 1992 distribution of Grand Casino-Hinckley revenues.

Chapter

<u>Section 1.</u> Band Revenue - Grand Casino Hinckley Revenues. The Band Assembly hereby appropriates and authorizes the expenditure of one million four hundred eighty five thousand five hundred thirty dollars and sixty five cents (\$ 1,485,530.65) from the Band revenues derived from the June 1992 distribution of the Grand Casino Hinckley revenues for the following:

<u>Section 1.01:</u> The Band Assembly hereby appropriates fifty one thousand dollars and no cents (\$ 51,000.00) for the Executive Director position and related expenses of the Mille Lacs Band Housing Authority.

Section 1.02: The Band Assembly hereby appropriates twenty thousand dollars and no cents (\$ 20,000.00) for the Reservation Clean Up Project.

Section 1.03: The Band Assembly hereby appropriates seven hundred twenty thousand dollars and no cents (\$ 720,000.00) for the start up of ceremonial buildings for District I and III (\$ 360,000.00 per building).

Section 1.04: The Band Assembly hereby appropriates one hundred thousand dollars and no cents (\$ 100,000.00) for district administrators and other related line items for District II and III (\$ 50,000.00 each).

<u>Section 1.05:</u> The Band Assembly hereby appropriates fifty one thousand dollars and no cents (\$ 51,000.00) for the start up funds of the Planner position.

Section 1.06: The Band Assembly hereby appropriates one hundred fifty thousand dollars and no cents (\$ 150,000.00) for the Education curriculum and staffing needs.

<u>Section 1.07:</u> The Band Assembly hereby appropriates one hundred thousand dollars and no cents (\$ 100,000.00) for the Mille Lacs Band Housing Authority for Elderly Renovation Program for all three districts.

Section 1.08: The Band Assembly hereby appropriates one hundred thousand dollars and no cents (\$ 100,000.00) for the start up funds of the Day Care Project. Section 1.09: The Band Assembly hereby appropriates one hundred ninety three

thousand five hundred thirty dollars and sixty five cents (\$ 193,530.65) for

Cunningham Architects.
