Band Assembly Bill 05-01-10-92

A bill of tribal government to appropriate funds from the Net Revenue allocation Schedule Accounts of the Mille Lacs Band of Chippewa Indians.

The District II Representative introduced the following bill on the 20th day of May, 1992

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Net Revenue Allocation Schedule Accounts.

Chapter 74

<u>Section 1.</u> Net Revenue Allocation Schedule Accounts. The Band Assembly hereby appropriates and authorizes the expenditure of one hundred sixty four thousand four hundred thirteen dollars and seventy three cents (\$164,413.73) from the Net Revenue Allocation Schedule Account for the following:

Section 1.01: The Band Assembly hereby appropriates ninety nine thousand four hundred thirteen dollars and seventy three cents (\$99,413.73) from Land Acquisition for the following: twenty five thousand eight hundred seven dollars and seventy eight cents (\$25,807.78) for property tax assessments under Operator/Maintenance line item, thirty eight thousand one hundred five dollars and ninety five cents (\$38,105.95) to the Mille Lacs Reservation Department of Natural Resource Administrative Account and twenty five thousand dollars and no cents (\$25,000.00) to Edgewater Realty for purchase of property in McGregor, Minnesota and ten thousand five hundred dollars and no cents (\$10,500.00) for Jerry Saliterman lot.

<u>Section 1.02:</u> The Band Assembly hereby appropriates thirty thousand dollars and no cents (\$30,000.00) for the Law Enforcement Account for operating cost.

<u>Section 1.03:</u> The Band Assembly hereby appropriates twenty five thousand dollars and no cents (\$25,000.00) from the Long Term Saving Account for the Discretionary Loan Fund.

<u>Section 1.04:</u> The Band Assembly hereby appropriates five thousand dollars and no cents (\$5,000.00) from the Day Care Account for operating costs.

Section 1.05: The Band Assembly hereby appropriates five thousand dollars and no cents (\$5,000.00) from the Judicial Account for court operating costs.
