Band Assembly Bill 05-01-03-92

A bill of tribal government to appropriate funds from the Net Revenue Allocation Schedule of the Mille Lacs Band of Chippewa Indians.

The District II Representative introduced the following bill on the 26th day of February, 1992.

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Net Revenue Allocation Fund Account.

Chapter 81

Section 1. Net Revenue Allocation Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of two hundred twenty thousand four hundred twenty three dollars and thirty six cents (\$220,423.36) from the Net Revenue Allocation Account for the following:

Section 1.01: The Band Assembly hereby appropriates one hundred five thousand five hundred forty four dollars and thirty six cents (\$105,544.36) from the Government Development Account for the FUTA expense of the Mille Lacs Reservation.

Section 1.02: The Band Assembly hereby appropriates fifty eight thousand six hundred thirty nine dollars and no cents (\$58,639.00) from the General Government Account for salary increases for the Commissioners, of the Mille Lacs Reservation, retroactive to October 1st, 1991.

Section 1.03: The Band Assembly hereby appropriates seven thousand four hundred forty dollars and no cents (\$7,440.00) for salary of Olaf Thomas - Urban Representative Mille Lacs Band Assembly from the General Government Account of the Mille Lacs Reservation.


Section 1.04: The Band Assembly hereby appropriates eight hundred dollars and no cents (\$800.00) for Brainerd Community College Annual Pow-Wow from the Community Donations Account of the Mille Lacs Reservation.

Section 1.05: The Band Assembly hereby appropriates forty eight thousand dollars and no cents (\$48,000.00) for Himmelberger tract in Aitkin County, District II of the Mille Lacs Reservation, from the Land Reacquisition Account of the Mille Lacs Reservation.







CLERK CERTIFICATION FOR BAND ASSEMBLY BILLS


