

Band Assembly Bill 05-01-04-92

A bill of tribal government to appropriate funds from the Net Revenue Allocation Schedule of the Mille Lacs Band of Chippewa Indians.

The District I Representative introduced the following bill on the 18th day of March, 1992.

Preamble

Be it enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Net Revenue Allocation Fund Account.

Chapter 81

Section 1. Net Revenue Allocation Fund Account. The Band Assembly hereby appropriates and authorizes the expenditure of two hundred thirty two thousand one hundred twenty five dollars and no cents (\$232,125.00) from the Net Revenue Allocation Account for the following:

Section 1.01: The Band Assembly hereby appropriates fifty six thousand dollars and no cents (\$56,000.00) from the Land Reacquisition Account of the Mille Lacs Reservation for the final payment of the Timber Hills property.

Section 1.02: The Band Assembly hereby appropriates fifteen thousand one hundred twenty five dollars and no cents (\$15,125.00) from the Land Reacquisition Account of the Mille Lacs Reservation for the down payment and market analysis on the Jarosh property.

Section 1.03: The Band Assembly hereby appropriates fifty one thousand dollars and no cents (\$51,000.00) from the Land Reacquisition Account of the Mille Lacs Reservation for payment on the Valentine Property.

Section 1.04: The Band Assembly hereby appropriates fifty thousand dollars and no cents (\$50,000.00) from the Court Account of the Mille Lacs Reservation for general operating funds.

Section 1.05: The Band Assembly hereby appropriates thirty thousand dollars and no cents (\$30,000.00) from the Corporate Account of the Mille Lacs Reservation for general operating funds.

Section 1.06: The Band Assembly hereby appropriates thirty thousand dollars and no cents (\$30,000.00) from the Elderly Housing/Housing Account of the Mille Lacs Reservation for miscellaneous construction on homes.






