An ordinance of supplemental appropriation for the Court of Central Jurisdiction of tribal government for fiscal year 1993.

The District I Representative introduced the following bill on this 8th day of October, 1992.

## Preamble

It is enacted by the Band Assermbly of the Mille Lacs Band of Chippewa Indians a supplemental appropriations for the Court of Central Jurisdiction for fiscal year 1993.

## Chapter 70

<u>Section 1:</u> Court of Central Jurisdiction. The Band Assembly hereby appropriates supplemental programmatic funds of the Court of Central Jurisdiction for the Net Revenue Allocation from April 1991 to September 1991.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of the Net Revenue Allocation Account by thirty nine thousand one hundred sixty six dollars and sixty three cents (\$ 39,166.63) for the Court of Central Jurisdiction. Which amends the total to read two hundred five thousand seven hundred seventy eight dollars and sixty three cents (\$ 205,778.63).

<u>Section 1.02:</u> Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds and specifically allocates these funds for the following grants and contracts: Net Revenue Allocation - \$ 39,166.63.

Section 2: Amendment to Section 2. Personnel. The Band Assembly hereby authorizes an additional amount of eight thousand seven hundred dollars and no cents (\$ 8,700.00) as salary compensation and one thousand eight hundred twenty dollars and fifty two cents (\$ 1,820.52) for fringe benefits related to salary. This brings the total to ninety two thousand eight hundred twenty four dollars and no cents (\$ 92,824.00) as salary compensation and twenty three thousand six hundred ninety two dollars and seventy six cents (\$ 23,692.76) for fringe benefits related to salary.

<u>Section 3:</u> Amendment to Section 3. Communications. The Band Assembly hereby authorizes an additional two thousand five hundred twenty four dollars and no cents (\$ 2,524.00) for communication expenses for the Court of Central Jurisdiction. This brings the total to five thousand twenty four dollars and no cents (\$ 5,024.00).

Section 4: Amendment to Section 4. Travel/Per diem. The Band Assembly hereby authorizes an additional seven thousand one hundred sixty six dollars and sixty three cents (\$ 7,166.63) for travel in the categories of monthly mileage, trip travel, trip per diem, in-state travel and out-of-state travel. This brings the total to twenty four thousand five hundred ninety dollars and fifteen cents (\$ 24,590.15).

<u>Section 5:</u> Amendment to Section 5. Technical Assistance. The Band Assembly hereby authorizes an additional five thousand dollars and no cents (\$ 5,000.00) for technical assistance expenses for the Court of Central Jurisdiction. This brings the total to ten thousand dollars and no cents (\$ 10,000.00).

Section 6: Amendment to Section 6. Equipment/Supplies. The Band Assembly hereby authorizes an additional ten thousand two hundred seventy eight dollars and no cents (\$ 10,278.00) for equipment and supplies under the Court of Central Jurisdiction. This brings the total to twelve thousand six hundred twenty five dollars and twelve cents (\$ 12,625.12).

Section 7: Amendment to Section 9. Court of Appeals. The Band Assembly hereby authorizes an additional one thousand dollars and no cents (\$ 1,000.00) for court of appeals under the Court of Central Jurisdiction. This brings the total to six thousand dollars and no cents (\$ 6.000.00).

Section 8: Amendment to Section 10. Show Cause/Trial/Jury. The Band Assembly hereby authorizes an additional two thousand six hundred seventy seven dollars and forty eight cents (\$ 2,677.48) for court cost expenses in all proceedings of trials for the Court of Central Jurisdiction. This brings the total to nine thousand six hundred seventy seven dollars and forty eight cents (\$ 9,677.48). BAND ASSEMBLY BILL 05-02-04-93
