

## Ordinance 09-93

An ordinance of tribal government to appropriate funds from the Band Revenue derived from the August, 1992 distribution of Grand Casino-Hinckley revenues.

The District I Representative introduced the following bill on the 9th day of October, 1992.

### Preamble

It is enacted by the Band Assembly for the Mille Lacs Band of Chippewa Indians for the purpose of appropriating funds out of the Band Revenue derived from the August, 1992 distribution of Grand Casino-Hinckley revenues.

### Chapter

Section 1: Band Revenue - Grand Casino Hinckley. The Band Assembly hereby appropriates seven hundred eleven thousand nine hundred ninety four dollars and ten cents (\$ 711,994.10) from the Band revenues - Grand Casino Hinckley revenues for the following:

Section 1.01: The Band Assembly hereby authorizes six thousand six hundred eighty dollars and thirty eight cents (\$ 6,680.38) for Braun Intertech.

Section 1.02: The Band Assembly hereby authorizes one hundred nine thousand nine hundred forty seven dollars and sixty cents (\$ 109,947.60) for planning aid for Chemical Dependency.

Section 1.03: The Band Assembly hereby authorizes twenty thousand dollars and no cents (\$ 20,000.00) for Social Nutrition Elderly Program.

Section 1.04: The Band Assembly hereby authorizes forty three thousand nine hundred dollars and no cents (\$ 43,900.00) to Education Administration for school vehicles.

Section 1.05: The Band Assembly hereby authorizes twenty six thousand one hundred fifty one dollars and no cents (\$ 26,151.00) for JTPA Placement Services.

Section 1.06: The Band Assembly hereby authorizes one hundred sixty five thousand seven hundred seventy five dollars and twelve cents (\$ 165,775.12) to the Public Works Department.

Section 1.07: The Band Assembly hereby authorizes one hundred thousand dollars and no cents (\$ 100,000.00) to Elderly Services Coordination Program.

Section 1.08: The Band Assembly hereby authorizes one hundred fifty thousand dollars and no cents (\$ 150,000.00) to Comstock & Davis.

Section 1.09: The Band Assembly hereby authorizes four thousand eight hundred dollars and no cents (\$ 4,800.00) for Law Interns' mileage.


Section 1.10: The Band Assembly hereby authorizes sixty thousand dollars and no cents (\$ 60,000.00) to purchase a new unit for additional office space.

Section 1.11: The Band Assembly hereby authorizes twenty four thousand seven hundred forty dollars and no cents (\$ 24,740.00) for Communication Specialist Budget to be reimbursed to ANA.
