

ORDINANCE 27-94

An ordinance of supplemental appropriation for the governmental operations of the Executive Branch of tribal government for fiscal year 1994.

The District II Representative introduced the following bill on the 12th day of July, 1994.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation funds for governmental operations for fiscal year 1994.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Roads, Multi Media Program, EAP program, Clinic, JTPA program, and NASS student activity/Japan trip, Tribal operations under the Public Works, Natural Resources, Health and Human Services, Economic Development, and Education Administration and Administration for the fiscal year 1994.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of ninety-eight thousand seven hundred fifty-three dollars and no cents (\$98,753.00) for the Roads Program, one hundred seventeen thousand three hundred seventy-one and no cents (\$117,371.00) for the Multi Media Program and Natural Resources, nineteen thousand one hundred fifty-four and no cents (\$19,154.00) for the EAP Program, forty-five thousand three hundred sixty-three dollars and no cents (\$45,363.00) for the Clinic (Patient Care) Program, one thousand three hundred fifty-five dollars and no cents (\$1,355.00) for the JTPA II B program, and nineteen thousand six hundred eleven dollars and forty-one cents (\$19,611.41) for Japan trip (NASS), fifteen thousand and no cents (\$15,000.00) for Tribal Operations.

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:
