ORDINANCE 25-94

A ordinance of supplemental appropriation and net carry over FY93 for the Education Administration of the Executive Branch of tribal government for fiscal year 1994.

The District II Representative introduced the following bill on the 7th day of June, 1994.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation funds for Education Administration for fiscal year 1994.

Chapter 78

<u>Section 1:</u> Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the PIC 5 Program, Equalization Aid Program, Handicapped Program, Operating & Maintenance Program, and Curriculum Development Program under the Education Administration for the fiscal year 1994.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of twenty five thousand dollars and no cents for the (\$25,000.00) PIC 5 Program, thirteen thousand six hundred fifty four and no cents (\$13,654.00) for the Equalization Aid Program, twenty-two thousand seven hundred ten dollars and no cents (\$22,710.00) for the Handicap Program, fourteen thousand seven hundred thirty and no cents (\$14,730.00) for the Operating & Maintenance Program and thirty-five thousand eight hundred twenty four dollars and no cents (\$35,824.00) for the Curriculum Development Program under the Education Administration.

<u>Section 1.02:</u> Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:
