

**Ordinance 06-95**

An ordinance of supplemental appropriation for the Health and Human Services Administration, Public Works Administration and Administration for the governmental operations of the Executive Branch of Tribal Government fiscal year 1995.

The District III Representative introduced the following bill on the 14th day of October, 1994.

**Preamble**

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

**Chapter 78**

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Food Commodity construction, Homeless program, Office of Drug Policy/Prevention Program, Roads program, census program, and legal services, for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of twenty thousand dollars and no cents (\$20,000.00) for Food Commodity renovation, three hundred dollars and no cents (\$300.00) for the homeless program, thirty thousand dollars and no cents (\$30,000.00) for Office of Drug Policy/Prevention, two hundred seven thousand four hundred twenty four dollars and no cents (\$207,424.00) for Roads program, twenty thousand and no cents (\$20,000.00) for legal services, one hundred thirty four thousand four hundred eighteen dollars and no cents (\$134,418.00), for Census project, under the Health and Human Services Administration, Public Works Administration and Administration.

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:
