BAND ASSEMBLY BILL 06-03-24-95

A bill of supplemental appropriation for the Governmental Operation of the Public Safety , Health and human Services, and Economic Development Administration of the Executive Branch of Tribal Government fiscal year 1995.

The District I Representative introduced the following bill on the 16th day of May, 1995.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

Chapter 78

<u>Section 1:</u> Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the, Public Safety, Health and Human Services, and Economic Development Administration programs for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of seventy five thousand dollars and no cents (\$75,000.00) for Public Safety, two thousand seven hundred thirty one dollars and no cents (\$2,731.00) for Health and Human Services and seven thousand nine hundred ninety five dollars and no cents (\$7,995.00) for Economic Development. Which amends the total to read twenty eight million one hundred three thousand three hundred fifty two dollars and seventeen cents (\$28,103,352.17)

<u>Section 1.02:</u> Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Tribal Operation: Public Safety	<u>Supplemental:</u> \$75,000.00	<u>Amended Amount:</u> \$ 637,189.00
Health and human Services	\$ 2,731.00	\$3,609,883.69
Economic Development	\$ 7,995.00	\$1,684,580.20

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under one hundred thousand and up to 5% if the program is one hundred thousand dollars or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
