

BAND ASSEMBLY BILL 06-03-15-95

An amendment to bill 06-02-33-94 of supplemental appropriation for the governmental operations of the Public Works Administration and Education Administration of the Executive Branch of Tribal Government, funds for fiscal year 1995.

The District I Representative introduced the following bill on the 18th day of January, 1995.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Project BE-94-415, Nay-Ah-Shing School Program Activities, NASS Ailce Grant Program and NASS Transportation for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of forty eight thousand dollars and no cents (\$48,000.00) for upgrading septic and wells, two thousand five hundred dollars and no cents (\$2,500.00), for the Central Initiative Fund Grant, thirty-seven thousand three hundred dollars and no cents (\$37,300.00) for the NASS AILCE Grant Program, thirteen thousand three hundred dollars and no cents (\$13,300.00) for the NASS Transportation program, under the Public Works Administration and Education Administration for the governmental operations of the Mille Lacs Band of Chippewa Indians, which amends the total to read twenty-two million one hundred five thousand six hundred three dollars and ninety-nine cents (\$22,105,603.99).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:
