BAND ASSEMBLY BILL 06-03-25-95

A bill of supplemental appropriation for the Governmental Operation of the Natural Resources and Education Administration of the Executive Branch of Tribal Government fiscal year 1995.

The District _III_ Representative introduced the following bill on the 30th day of May, 1995.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

Chapter 78

<u>Section 1:</u> Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Natural Resources and Education Administration programs for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of fourteen thousand, eight hundred forty eight dollars and no cents (\$14,848.00) for Natural Resources and three hundred two thousand four hundred eighty five dollars and no cents (\$302,485.00) for Education, which amends the total to read twenty eight million four hundred twenty thousand six hundred eighty five dollars and seventeen cents (\$28,420,685.17).

<u>Section 1.02:</u> Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:

Tribal Operation:Supplemental:Amended Amount:Natural Resources\$ 14,848.00\$2,976,769.00Education\$302,485.00\$5,456,473.57

Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under one hundred thousand and up to 5% if the program is one hundred thousand dollars or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded
