

BAND ASSEMBLY BILL 06-03-16-95

A Bill of supplemental appropriation for the governmental operations of the Health and Human Services Administration and Education Administration of the Executive Branch of Tribal Government, funds for fiscal year 1995.

The District 1 Representative introduced the following bill on the 16th day of February, 1995.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

Chapter 78

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Administration Cost Grant, Exemplary Schools Grant, Substance Abuse Grant, Drug and Alcohol Federal Grant, Special Education Grant, EAP '95 NFA #3, EAP '95 NFA #4, EAP '95 NFA #5 for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of one hundred ninety eight thousand one hundred dollars and no cents (\$198,100.00) for Administration Cost Grant, nine thousand six hundred and no cents (\$9,600.00) for exemplary schools Grant, five thousand seven hundred and no cents (\$5,700.00) for Substance Abuse Grant, two hundred dollars and no cents (\$200.00) for Drug and Alcohol Federal Grant, eight hundred ninety five dollars and no cents (\$895.00) for Special Education Grant, five thousand five hundred seventy seven dollars and no cents (\$5,577.00), for EAP '95 NFA #3, twelve thousand two hundred thirty six dollars and no cents (\$12,236.00) for EAP '95 NFA #4, Ten thousand dollars and no cents (10,000.00) for EAP 95; NFA #5 under the Education Administration and Health and Human Service Administration for the governmental operations of the Mille Lacs Band of Chippewa Indians, which amends the total to read twenty-two million four hundred seventy nine thousand nine hundred eleven dollars and ninety-nine cents (\$22,479,911.99).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:
