**BAND ASSEMBLY BILL 06-03-23-95**

A bill of supplemental appropriation for the Governmental Operation of the Public Works, Administration, Community Development, Health and Human Services, and Economic Development Administration of the Executive Branch of Tribal Government fiscal year 1995.

The District II Representative introduced the following bill on the 5th day of May, 1995.

**Preamble**

Be it enacted by the Band Assembly of the Mille Lacs Band of Chippewa Indians for the purpose of supplemental appropriation of funds for governmental operations for fiscal year 1995.

**Chapter 78**

Section 1: Governmental Operations. The Band Assembly hereby appropriates supplemental programmatic funds for the Community Development Program, Economic Development, Health and Human Services, Public Works and Administration programs for the fiscal year 1995.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the supplemental appropriation of one hundred one thousand dollars and no cents (\$101,000.00) for Public Works, sixty thousand dollars and no cents (\$60,000.00) for public safety, fifty eight thousand dollars seventy four dollars thirty-seven cents (\$58,074.37) for Natural Resource, eleven thousand three hundred forty five dollars and thirty eight cents (\$11,345.38) for Administration and two hundred sixty thousand dollars and no cents (\$260,000.00). Which amends the total to read twenty eight million forty eight thousand nine hundred twenty five dollars and twenty-one cents (\$28,048,925.21).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the supplemental expenditure of programmatic funds for the following:


Section 1.03: Amendment to Section 11. The Band Assembly hereby authorizes commissioners to approve budgetary transfers within programs up to \$2,500.00, provided that the transfers are allowable under grant provisions, if applicable and that the Office of Management and Budget concurs with the transfers. For transfers over \$2,500.00, the Band Assembly hereby authorizes the Administrative Policy Board to approve budget transfers within programs of up to 10% of the total program budget within a given budget line if the program is under one hundred thousand and up to 5% if the program is one hundred thousand dollars or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
